Purpose: Presentation of the company as well as interaction with our users

The purpose of data processing on our fan page is to provide information about our products and services, combined with the possibility for users to interact with us in a targeted manner. The legal basis for the data processing is Art. 6 para. 1 lit. f DSGVO. Our legitimate interest is in particular our business interest in sharing information with our users and being able to communicate with them.

Data will only be passed on to the authorities if overriding legal provisions apply.

If we publish images and sound recordings of individuals, this is done on the basis of consent (legal basis: Art. 6 para. 1 lit. a DSGVO) or on the basis of a contractual assignment of rights of use (legal basis: Art. 6 para. 1 lit. b DSGVO).

Use of Facebook Insights

We place advertisements on Facebook and use Facebook Insights to evaluate the behaviour of our target group in the context of interaction with our site. The targeting of advertising is a legitimate interest of our company. The users of Facebook Insights are informed of this; the responsibility for data collection lies primarily with Meta Platforms Ireland Ltd. Countervailing interests of users worthy of protection (display of individual target group-optimised advertising) are not predominant. The legal basis for us is Art. 6 para. 1 lit. f DSGVO.

Third country transfer

It is not excluded that data from users are processed on systems outside the European Union. Data is only transferred to third countries if the requirements of Art. 44 et seq. DSGVO are fulfilled.
