Purpose and legal basis of data processing

For information about our products, services and news we operate a channel on the video portal of the company Vimeo.com, Inc., 330 West 34th Street, 5th Floor, New York, New York 10001, USA.

The purpose of data processing on our Vimeo channel is to provide information about products, services and news, combined with the possibility for users to interact with us in a targeted manner. The legal basis for the data processing is Art. 6 para. 1 lit. f GDPR. Our legitimate interest is in particular our business interest in sharing information with visitors to our Vimeo channel and being able to communicate with them.

If we publish images of individuals, this is done with the consent of the individuals (legal basis: Art. 6 para. 1 lit. a GDPR), on the basis of a contractual agreement (legal basis: Art. 6 para. 1 lit. b GDPR) or in exceptional cases on the basis of legitimate interests (legal basis: Art. 6 para. 1 lit. f. GDPR in conjunction with § 23 para. 1 no. 3 Kunsturhebergesetz).

Data processing by Vimeo

Transfer to third countries

We would like to point out that the transfer of personal data to the USA has been judged by the ECJ to be fundamentally unsafe without further security measures, as it cannot be ruled out that US security authorities will gain access to this data.



Your right to information, rectification, deletion and data portability

You may avail yourself of your right to information, rectification and deletion of data at any time. Simply contact us using one of the methods described above. We store your data for as long as is necessary to fulfill the purpose we are pursuing or as required by law. Should you require data to be deleted, which we are still legally obligated to retain, access to your data will be restricted (blocked). You can exercise your right to data portability, insofar as the technical possibilities are available at the recipient and at our company.

Right of appeal
